Memberships

- Memberships will run for the year from joining. A reminder will be sent by email to the vaulting group contact.
- Members lapsing beyond one month will no longer be considered members and will be liable for a £25 administration fee.
- All Vaulters should register under the relevant category for them.
- All Coaches / Lungers / Judges must be full members and complete the training register.
- BEV is run by volunteers. Please allow time for renewals and new memberships to be processed before competitions and access to the member's area of the website can be gained.
- Members only information can be gained from the member's area of the website by using membership number and date of birth.

Categories

1. Existing Groups £30. New Groups £20

This covers Committees and occasional adult helpers of affiliated groups to be covered by UK third party liability insurance while acting on behalf of the group. Rulebook is available on the web-site www.vaulting.org.uk

2. Adult member - aged 16 years and over on 31st December in the year of renewal £40

This covers all active members i.e. vaulters, coaches, lungers, judges, etc. Third party liability is included. The cost also covers the right to enter affiliated competitions, vote for committee members, coaching levels, award schemes, attend BEV courses, BEF Fees and administration e.g. auditing of accounts.

3. Youth member – aged 15 years and under on 31st December in the year of renewal £30

This covers vaulters only and includes all items as an adult member, except the right to vote in elections. Youth members attending competitions and courses must be accompanied by an adult member. Youth membership allows vaulters to compete in all affiliated classes where they are eligible to compete.

4. Horses £40

This covers all horses competing at affiliated competitions.

5. Associate member £15

Covers non-competing members and regular adult helpers.

6. Temporary member £1

This membership covers individual vaulters for one trial session with a club/group.

7. Family membership

Join either, 4 adults, 2 adults & 2 youths or 1 adult & 3 youths and the cheapest family member is free. Please complete one form per member and pay for only the first three.

BRITISH EQUESTRIAN VAULTING

Code of Conduct

As a member of British Equestrian Vaulting (BEV), I acknowledge my obligation to uphold and adhere to the highest standards of horsemanship, sportsmanship, clean sport and behavior whenever I am representing BEV.

As a BEV member I will know and comply with all pertinent rules of BEV and honour the principals of fair play in sports. I will place the interests of the organisation above my own and respect the decisions of its duly appointed / elected officials, made in the organisations best interests.

- I understand that Equestrian Vaulting at any standard has inherent risk and that all horses may react unpredictably on occasions.
- I may fall off and could be injured. I accept that risk.
- I understand that instructions are given for my safety and agree to follow instructions given to me by coaches at the vaulting club or officials
- I understand that the vaulting club will make decisions based on information I give them and agree to always be honest and volunteer information about:
 - my abilities and Equestrian vaulting experience
 - any previous Equestrian vaulting accidents
 - any medical condition(s) which may affect my ability to vault
- I understand that children are at particular risk around horses and agree that I will keep any children that I am responsible for, under close supervision when they are not being coached by the vaulting club.
- I understand that the vaulting club may refuse my request to vault for safety and operational reasons.
- I understand that competing carries enhanced risk over and above general equestrian vaulting and agree that if I chose to participate in any competition or event, it is up to me to ensure that I have the experience and ability to vault. If I am in any doubt, I will use my judgement and experience and not enter.

I acknowledge my responsibility to ensure that my team who accompany me whenever I am competing and/or representing my country will also abide by this code of conduct.

I also acknowledge that I serve as an ambassador for my sport, BEV and my country and I will endeavour at all times to reflect credit on them through my conduct, dress and behavior.

I understand and accept that serious or repeated transgressions of these codes or BEV rules may be grounds for suspension from BEV, or other appropriate disciplinary action. In addition I agree to be bound by selection procedures established by BEV wherever applicable.
